Developed council to establish short/long term goals for DEI efforts/initiatives for our campus community.

DEI doesn't necessarily mean the same thing to faculty as it does to staff, admin, and students.

Led to training opportunities and cultural climate audit and engage in racial equity training to campus and faculty. How our words/language matter specifically on implicit bias, and LGBTQIA initiatives.

Face to face, virtual, faculty are mandated to engage in two faculty advancement trainings per year.

Report findings of cultural climate audit.

Working with DEI council to establish a dedicate office/director for DEI on campus Used external partner Multiethnic Advocates for Cultural Competency (MACC) out of Columbus for the audit/training.

Many faculty are concerned with SB 83 and its impact on our current efforts.
