SB 83 vote likely upcoming next week, along with HB 151 testimony hearing Working on an OFC testimony document similar to that we did for SB 83. Working to get more than the 500+ testimonies for the next hearing

The wording says 30 credits for full time, doesn't pro rate for 9 months as the original bill does. Says the universities have to define "full time" for themselves

"A different version of SB 18 emerged at the hearing on Monday, and the tenure ban was gone. State Rep. John Kuempel, a Republican and chair of the Higher Education Committee in the House, said the substitute reflects that faculty tenure is a necessity for the state's colleges to remain competitive."

Chair-extends words of appreciation for willingness to support and speak on our behalf

Akron- view on current climate between faculty and admin? Seeing evidence of collaboration between bodies, but depends on institution. May not be the best voice to interpret current climate overall.

Ohio State- Did Cirrino reach out to you regarding SB 83 and accomplishing goals?

Spoken with Senator. Not involved in framing/writing bill. Spoke about budget. He may say "when the bill was introduced, there was criticism but not response with how to amend the bill" others may say he didn't reach out before/after often there isn't much reaching out before bill is introduced.

BGSU- extends appreciation for your collaborative efforts

Kent State- Echoes appreciation for often listening. Wonders about representatives coming to campuses to see how things actual are, rather than responding to a potentially small group who loudly complain about issues that are not as prominent as they make them.

G- Hopeful that regardless of legislative outcome, that there are still ways the spirit of shared values/responsibilities can be sustained and grown. Without faculty we don't have universities and can't serve students.

Chair- shift in person meeting to invite legislators to meet to discuss mental health among universities

Youngstown- concerned about attacks on DEI

Ohio State- echoing focus on DEI. Concern about mental health is one of DEI.

SB 135- do you think there really are gaps? Student evals are being directly asked questions that could put jobs in danger. Perhaps say, we have a bill and we can rely on that.

The senator may say that 35 is meant to protect everyone on all sides. That individuals can express what they like, but institutions cannot.

Wright State- collaboration and reaching out only works whan all are working in good faith. How do we proceed when that isn't the case?
