- History of OCTC start Distributed model of professional development
- 40 colleges represented
- Start with certificate of inclusive teaching from OCTC
- Funding has come from Sub-Grant and labor from individuals working at institutions
- Currently working on expanding further to do more collaboration across campuses multiple institutions
- Little funding to do as much. Need to work on funding to make initiatives sustainable
- Request to distribute OCTC link widely across your institutions

- Work on grants or institutional membership fees? Line item from the state?
- Ask Faculty to sign up for inclusive teaching endorsement
- Or try to make your development work available to institutions across the state, reach out to OCTC
- Trying to continue building this as a collective (adjuncts at multiple institutions, grad students who are moving, underresourced institutions, etc)

# 4. Campus examples of shared governance successes and challenges

(member suggested topics include concerns about DEI initiatives on our campuses and across the state, leadership transitions, post-tenure review processes, adjunct compensation and parking fees, other)

- BG- adjunct (admin led task force looking into all aspects of Adjunct work), president/provost evaluation in CBA but is vague hasn't been done yet for current admin request for peer institution practices
- Central- revising guidelines, etc for new teaching assignments, working on preparing for HLC visit
- Cleveland- working on realignment, finalizing new bylaws and guidelines (for newly created colleges), reviewing curriculum, finished meeting of aaup EC formation of committee for next contract negotiation
- Miami- new provost transition, incident with admin evaluation FOIA request for past provost, student paper requested and published all info. Adjunct pay discussions (got a raise two years ago, up for discussion likely moving forward)
- NEOMED- approaching new dean for college of medicine, deciding whether or not to go forward with provost, positive HLC report, completed Academic Freedom policy
- OSU- Presidential search committee starting, lobbying for faculty/students/staff
  representation to advise the committee, wrote letter to board for more info
  about resignation (got a response, but no information), council decided to write
  again and advocate for representation on committee
- Ohio- (student paper regularly submits foia request for evaluation publication) president search ongoing, response to "testing your faith" act, Dean searches ongoing.
- Akron- salary/job title investigation (about 1.5 year so far) consider a raise for part time faculty. Issues with transfer credits. Some want to go to automated service to compare descriptions. Senate opposed to it.
- UC- reduced money to colleges in recent years, started pushing back on reasons for reductions, university arguing that online TT faculty should be in bargaining

unit. Pushing back against that. SERB Hearing Transcripts: wardleea@miamioh.edu

- UT- Parking problematic (privatized), working on CBA, aaup dealing with number of arbitrations,
- WSU- upper admin turnover, revising new policy practices, workload policy put forward for revision before going to senate, prepping for bargaining
